The Beginning

Southeast Nebraska Community Action Council, Inc. (SENCA) was incorporated on May 2, 1966, in Humboldt, Nebraska as a private, non-profit 501(c)(3) corporation for the purpose (as stated in its articles of incorporation) of "developing and operating any and all community action programs and activities including, but not limited to those authorized or permitted by the Economic Opportunity Act of 1964." The incorporators of SENCA were Evelyn Cooper of Humboldt, and Cecil Davis of Pawnee City, and there were twenty-eight members of the first Board of Directors. The corporation was formed under the laws of Nebraska as a non-profit corporation. The SENCA service area included Cass, Johnson, Nemaha, Otoe, Pawnee and Richardson Counties in southeast Nebraska.

SENCA is one of nine Community Action Agencies formed in Nebraska during the initial formation and operation of the Economic Opportunity Act: SENCA – Humboldt Blue Valley Community Action Partnership - Fairbury Central Nebraska Community Action Partnership – Loup City Community Action Partnership of Lancaster and Saunders Counties – Lincoln Community Action Partnership of Mid-Nebraska - Kearney Community Action Partnership of Western Nebraska - Gering Eastern Nebraska Community Action Partnership – Omaha Northeast Nebraska Community Action Partnership – Pender Northwest Community Action Partnership – Chadron

Authorizing Legislation

The Economic Opportunity Act was passed during the administration of President Lyndon B. Johnson as one facet of the nationwide anti-poverty movement begun by President John F. Kennedy. Section two of the Act stated that it was "the policy of the United States to eliminate the paradox of poverty in the midst of plenty in this Nation by opening to everyone the opportunity for education and training, the opportunity to work, and the opportunity to live in decency and dignity." The Community Services Administration was then formed to oversee these programs. Programs authorized by the Act included the Job Corps, Work and Training for Youth and Adults, Work-Study Programs, Special Impact Programs, Urban and Rural Community Action Programs, Rural Loan Programs, Assistance for Migrant and Other Seasonally Employed Farm Workers, Employment and Investment Incentives, Work Experience and Training Programs, Day Care Projects, and Volunteers In Service To America (VISTA).

In 1981 the Congress of the United States abolished the Community Services Administration and authorized the Community Services Block Grant Act which shifted the administration of Federal anti-poverty funds to the individual states. In Nebraska, Community Services Block Grant (CSBG) funds are administered by the Department of Health and Human Services. Funding from CSBG is available "to provide a range of services and activities having a measurable and potentially major impact on the causes of poverty in the community" and to "remove obstacles and solve problems which block the achievement of self-sufficiency" in the areas of employment, education, housing, emergency assistance, nutrition, and health services. The act also authorized activities to encourage "greater participation in the affairs of the community" by low-income persons, "to coordinate and establish linkages between governmental and other social services," and "to encourage the use of entities in the private sector of the community in efforts to ameliorate poverty in the community."

Current On-Going Services

Community Services: Community Services Department's goals are aimed at the reduction of poverty, the revitalization of low-income communities, and the empowerment of low-income individuals and families to become self-sufficient.

Clothing Rooms

Community Action Centers Tecumseh and Pawnee City house clothing rooms. Clothing, household and furniture items are received by the agency in the form of donations. These donated items are provided to families in need at no charge, or sold to the general public at a nominal fee. The money received from the sale of these items is kept in the appropriate center fund to help defray the cost of daily operations and/or to help provide for families' needs that other funding sources might not cover.

Emergency Services

These services are available to provide basic needs and support to families in crisis who are unable to provide for themselves. This includes, but is not limited to food, clothing, emergency shelter, rent and utility assistance, basic essentials, landlord-tenant mediation, and crisis intervention.

Family Development

This is a strength-based program designed to assist families through a series of assessments. These assessments are used to identify the families' strengths and what barriers or obstacles they face in reaching self-sufficiency. Families are then assisted with writing goals and mobilizing resources to move in that direction.

Food Pantries

Food pantries are available to all persons in the SENCA service area who, because if unforeseen emergency, are in need of food. Food pantries are stocked by donations from various groups, organizations and other interested individuals. The food pantries also provide information about other nutrition programs, safe food preparation, and how to make your food dollars stretch. Private cash donations to the food pantry help provide perishable items on an asneeded basis. Food pantries are provided and donations accepted at the Outreach Offices and Community Centers in each of the six counties served by SENCA.

Project First

SENCA is involved in the Southeast Region Continuum of Care for the Homeless in southeast Nebraska. The Continuum of Care consists of service providers, housing authorities, clergy, school personnel, former homeless representatives and other interested groups or individuals. The mission of this group is "to address the needs of homeless/near-homeless persons and families." The group's vision is that "services for homeless/near-homeless are available through community support and education, collaboration, and resource development.

Nutrition

The meal program is designed to provide a nutritious, affordable meal to the area senior citizens. Meals on Wheels are home delivered by community volunteers to those individuals who are unable to take advantage of the social setting that the Congregate Meals have to offer. SENCA currently operates Congregate and Meals on Wheels in Pawnee and Johnson Counties at the Community Action Centers. Various forms of Congregate and Meals on Wheels programs are available in Nemaha and Richardson Counties.

Head Start: Head Start and Home Start are comprehensive child development programs which serve children from birth to age five, pregnant women and their families. They are child-focused programs and have the overall goal to increase the school-readiness of young children in low-income families. The program involves the whole family through the four cornerstones of Head Start: Child Development, Family Development, Community Development, and Staff Development.

Income eligibility for participation in the Head Start program is based on the Federal Income poverty guidelines. Guidelines allow for 10% of our enrollment to be above the poverty guideline. At least 10% of our enrollment slots are reserved for children with special needs that meet all other criteria.

The Head Start program was launched nation-wide in 1965. In 1968 SENCA began sponsoring Head Start programs in southeast Nebraska and currently serve families in Pawnee, Richardson, Nemaha, and Otoe counties. Today, as then, Head Start's approach is based on the philosophy that a child can benefit most from comprehensive, developmentally appropriate program, and that the child's entire family, as well as the community must be involved.

Housing: In October 1995 SENCA became designated as a Community Housing Development Organization (CHDO) to further its commitment to identifying the need for affordable housing, and obtaining and committing resources to develop safe and sanitary housing available to low to moderate income persons. To date, SENCA has secured funds for buying and building various Housing Development projects.

Weatherization: In 1975 SENCA started Weatherizing the homes of eligible households, with an emphasis being placed on the homes of elderly, persons with disabilities, and homes with small children. The goals of the Weatherization Program are to save energy by reducing heating and cooling costs and to ensure the health and safety of the households served. The average home experiences an 18.7% reduction in heating costs. Additional savings are achieved in cooling costs. This conservation of energy reduces Nebraska's dependence on imported energy and is a major contribution to the self-sufficiency of low-income persons allowing them to stretch their available income. Eligibility for the Weatherization program is 130% of the poverty guidelines.

Transportation: Pawnee County Transit began operation in April 1981. It is a countywide transit service serving the general public with priority for the elderly and disabled. The transit system operates on a regular schedule locally and in the surrounding area, and provides door to door service for trips within the county and out of area. Pawnee County Transit is operated under contract with the Pawnee County Commissioners.

Richardson County Transit began operation in 1994. It also serves the general public with priority given to elderly and handicapped. The transit system operates on a regular schedule locally and out of the area, and provides door to door service for trips within the county and out of area. Richardson County Transit is operated under contract with the Richardson County Commissioners.

Direct Employment: SENCA works in partnership with Experience Works and Foster Grandparents. Employees can also be hired from the Jobs Training Partnership Act.

Funding

SENCA receives grants and contracts from various governmental bodies to provide services deemed essential to the welfare of local citizens. Governmental funds must be matched and supplemented by local citizens, local cash and/or donations of time or goods. Programs are funded from a wide variety of sources and from the beneficiaries themselves whenever possible.

Independent public accountants annually audit SENCA accounts. Audits of the previous fiscal years have found no audit exceptions and found the financial statements to be in conformity with the terms of grant agreement and generally accepted accounting principles.

Volunteers

Every fiscal year approximately 1000 individuals dedicate around 16,000 hours of time in agency programs. This calculates into approximately \$220,000 in non-federal match funds. Local donations of time, talent and money are always welcome. Involvement of volunteers and people served in the SENCA programs is vital to the work of SENCA.
